Curbing Delhi's deadly Pollution

Arvind Kejriwal, Delhi's chief minister, appealed to city residents to observe the festival at home and banned the use of firecrackers, a traditional way of marking the holiday that also causes a spike in pollution.

Thus to spread this among the communities, RISE children holding the posters and banners informed the people about Pollution, its causes & solutions on Pollution Control Day following all the norms of Social distancing. National Energy Conservation Day



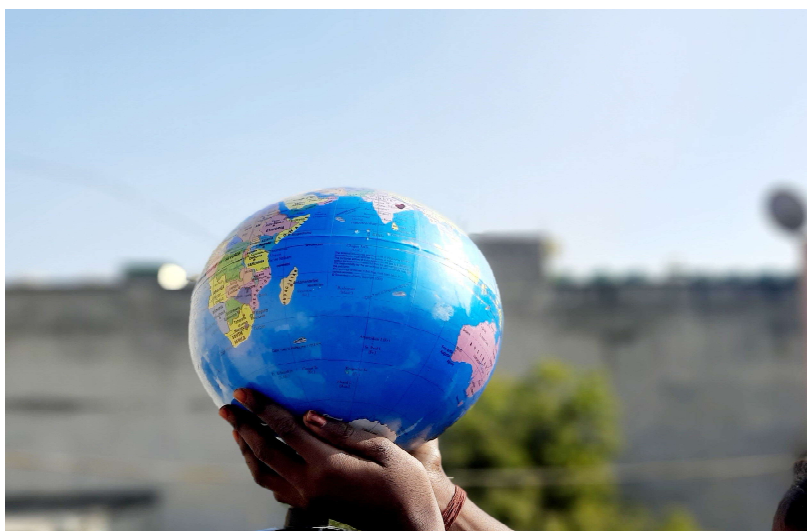

The Exciting Mathematics ...

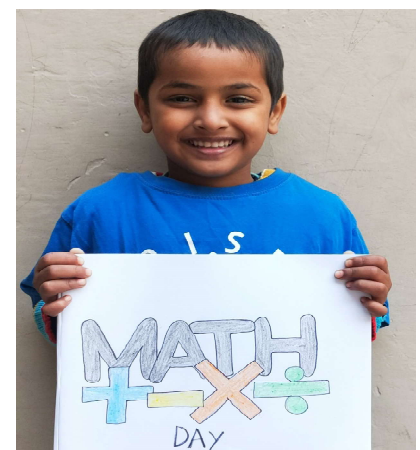

Munesh, a bright educators of RISE



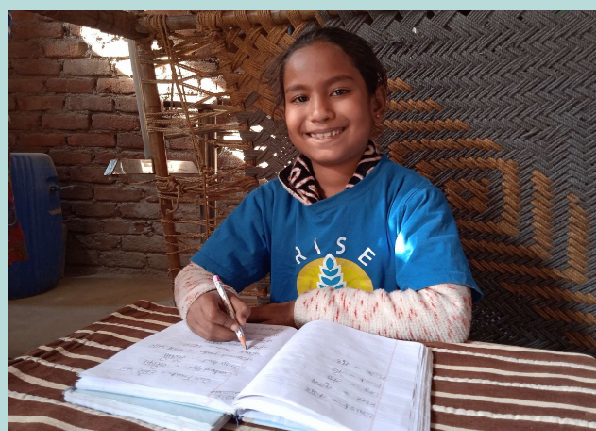
